

Member-At-Large Award

(Formerly the President's Award)

Objectives:

- The Member-At Large Award will honor an established WiNUP member-at-large who has exhibited *exceptional* leadership and service within EWRT/WiNUP for at least *six (6) years*.
- It will recognize the recipient's EWRT/WiNUP involvement and responsibilities at the international level and attendance at International Conferences.
- The Member-At-Large Award will promote awareness of the Member-at-Large Chapter.
- It will promote awareness of the recipient's contributions made to the industry which support WiNUP goals.
- It will promote awareness of the recipient's contributions to other professional organizations.

Eligibility:

Nominees must be active members for at least six (6) years.

Members must demonstrate long term commitment to the organization, which must be detailed in the nomination form.

An eligible member-at-large may be nominated by a fellow member-at-large or a member of the International Board of Directors, or may be self nominated.

The previous recipient is responsible for all aspects of selecting the next recipient which includes:

- Selecting a three-member committee to judge the nominees and tabulating committee members' evaluation forms.
- Notifying the Executive Director of the recipient's name. (Executive Director orders the award.)
- Presenting the award at the International Conference.

The committee chair selects members for the three-person judging committee.

Judges will take into consideration the nominee's involvement in EWRT/WiNUP over a period of six (6) years or more; leadership positions in the organizations internationally; leadership exhibited in other organizations and activities; and professional accomplishments. Nominees should describe how they have supported and continue to support EWRT/ WiNUP objectives.

Send the nomination form to the MAL Award Chair no later than June 15. (Each of the three judges will be sent a copy and a copy will be retained in the Executive Office.)
